Membership Agreement

1. Management has the right to suspend and/or terminate a membership for non-payment of dues, fees, or behavior detrimental to the enjoyment of the fitness center by other members or staff. If late on payment, the key card will not give access to the facility until the account is made current. If the card is lost or stolen, a \$10 replacement fee will be assessed.
2. It is agreed that a member may terminate membership from the Fitness center by giving in person or written notice of intent to cancel by the 15th of the month prior to the desired month of cancellation. If an annual contract was signed, the member will pay a penalty as follows: within 1-6 months of activating membership= \$150, within 6-12 months of activating membership=\$75. All accrued dues, penalty charges, and other charges for which the member may be liable are due at the time of termination. If by reason of death or permanent disability, the member is unable to continue the membership, the member shall be relieved of this contract upon legitimate medical verification. Should a member permanently move more than 30 miles from the area, the member shall be relieved of this contract upon legitimate verification of the move.
3. While the management and staff make a sincere effort to avoid equipment downtime or out of order status, member understands that from time to time, equipment may be out of order and will require various repairs and replacement lead times.
4. Member understands and agrees that the center shall not be responsible for any damaged, lost, or stolen personal property of member.
5. Smoking is strictly prohibited in any area of the club including interior exercise areas, exterior entry areas and restrooms. Illicit drugs and alcohol are not permitted inside the center at any time.
