Membership Agreement

1. Management has the right to suspend and/or terminate a membership for non-payment of dues, fees, or behavior detrimental to the enjoyment of the fitness center by other members or staff.
2. If late on payment, the key card will not give access to the facility until the account is made current. If the card is lost or stolen, a \$10 replacement fee will be assessed.
3. It is agreed that a member may terminate membership from Rockin' Fitness by giving in person or written notice of intent to cancel by two weeks prior to the next scheduled payment on their account.
4. If an annual contract was signed, the member will pay an early termination penalty as follows: within 1-6 months of activating membership \$150; within 6-12 months of activating membership \$75.
5. All accrued dues, penalty charges, and other charges for which the member may be liable are due at the time of termination.
6. If by reason of death or permanent disability, the member is unable to continue the membership, the member shall be relieved of this contract upon legitimate medical verification.
7. Should a member permanently move more than 30 miles from the area, the member shall be relieved of this contract upon legitimate verification of the move.
8. While the management and staff make a sincere effort to avoid equipment downtime or out of order status, member understands that from time to time, equipment may be out of order and will require various repairs and replacement lead times.
9. Member understands and agrees that the center shall not be responsible for any damaged, lost, or stolen personal property of member.
10. Smoking is strictly prohibited in any area of the club including interior exercise areas, exterior entry areas and restrooms. Illicit drugs and alcohol are not permitted inside the center at any time.

Waiver and Release Form

You have agreed to purchase a membership at a facility that allows you access at any time. As such, you are aware that there will be no supervision or assistance. You are also aware that if you are injured, become unconscious, or suffer a stroke or heart attack, that there will likely be no one to respond to your emergency and this facility has no duty to provide assistance to you. Even though this facility is equipped with surveillance cameras, it is likely that should you require immediate assistance, none will be provided. We HIGHLY recommend that you have a work out partner accompany you while at the club, but it is entirely up to you.

Because physical exercise can be strenuous and subject to risk of serious injury, the club urges you to obtain a physical examination from a doctor before using any exercise equipment or participating in any exercise activity. You (each member, guest, or participant) agree that if you engage in any physical exercise or activity, or use any club amenity on the premises or off premises including any sponsored club event, you do so entirely at your own risk. You agree that you are voluntarily participating in the use of this facility and assume all risks of injury, illness, or death. We are also not responsible for any loss of your personal property.

This waiver and release of liability includes, without limitation, all injuries which may occur, regardless of negligence, as a result of; (a) your use of all amenities and equipment in the facility and your participation in any activity, class, program, personal training, or instruction, (b) the sudden and unforeseen malfunctioning of any equipment and (c) your slipping and falling while in the club, or on the club premises, including adjacent sidewalks and parking areas.

You acknowledge that you have carefully read this “waiver and release” and fully understand that it is a release of liability. You expressly agree to release and discharge the club, and all affiliates, employees, agents, representatives, successors, or assigns, from any and all claims or causes of action and you agree to voluntarily give up or waive any right that you may otherwise have to bring legal action against the club for negligence, personal injury, or property damage.

Note: Should any part of this agreement be found by a court of law to be against public policy or in violation of any state statute or case precedence, then only that wording is removed and the remainder of this agreement is in full force.
